For convenience the Codes of Civil and Criminal Procedure have been included in the book and the sections amended or repealed are carried in the table. Following this arrangement the book contains a record of the laws repealed and a record of the year, chapter and title of the consolidated laws with a reference to the page in the supplement where the amendments and repeals are noted, and also a record of the laws amending or repealing various sections or parts of the consolidated laws and codes, arranged by the year of their enactment. The Practice Acts of 1920 also appear in the supplement. An index, which follows, gives the year and chapter of the consolidated laws and the number of the page where each law can be found. (Typographical errors above are due to OCR software and don't occur in the book.)
